1. Supplier identification

2. Privacy policy & cookies

1. Your personal data will be used to provide the information, goods and services offered through our website to you, for billing and order fulfillment.

5. We may disclose your personal data only when:

3. Returns // Right to cancel

1. You have the right to cancel the purchase of a good without having to give a reason at any time within seven days, beginning on the day after you receive the goods.
2. If you are in possession of the goods you are under the duty to retain them and take reasonable care of them. You must send the goods back to us to our contact address at your own cost as soon as possible once you have canceled your order.
3. Please put the return item carefully in its original packing and clearly state your order number. Items which are not packaged carefully or arrive damaged, unfortunately cannot be credited.
4. We reserve the right to make a charge not exceeding our direct costs of recovering the goods if you do not return the goods or return them at our expense.
5. Once you have notified us that you wish to cancel the order, any sum debited to us will be refunded to you as soon as possible and in any event within 30 days of your cancellation.
6. You will not have any right to cancel a purchase if it is made to your specifications (eg different size or color) or if it is clearly personalised.

4. Notices

1. All notices you send us must be sent to the contact details on this site (link). We may give notice to you at either the email or postal address you provide to us when making a purchase. (Notice will be deemed received and properly served 24 hours after an email is sent or three days after the date of posting of any letter.) In providing the service of any notice, it will be sufficient to prove, in the case of a letter, that the letter

was properly addressed, stamped and placed in the post and, in the case of an email that the email was sent to the specified email address of the addressees.
We are not responsible for the effects of a wrong address filled in when your order.
